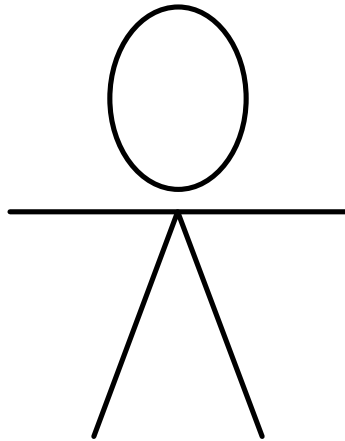

Human Resource Role Model

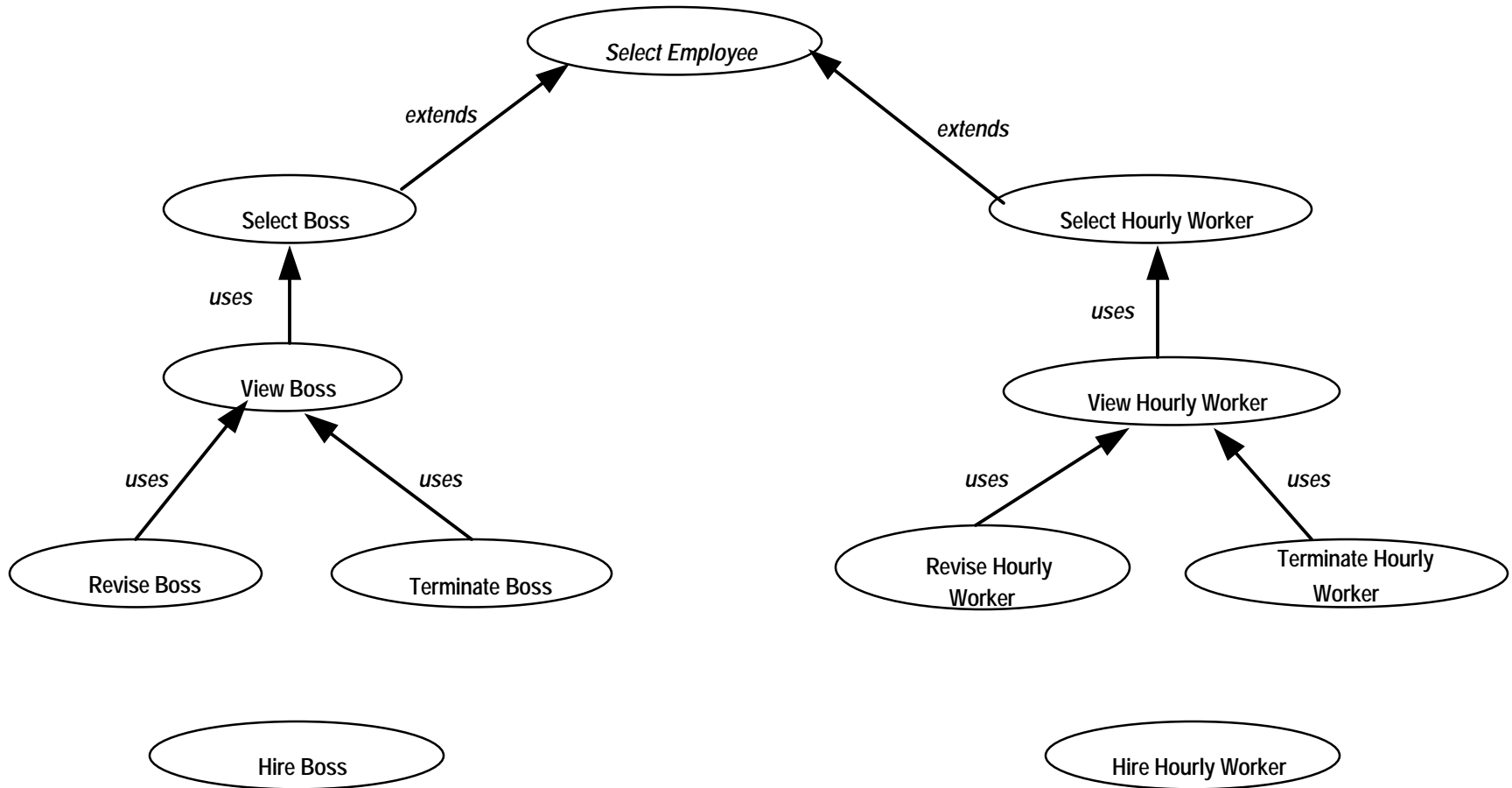
Payroll Clerk

enters data about new employees, updates data about employees and removes employee from the payroll system when they leave the company.

Human Resource Manager

views the current values selected employee records and needs to access the earnings of each employee.

— T — **Use Case Narrative:**
Select Employee

Is used to select an employee to view. User does not need to know Employee type.

USER INTENTION

SYSTEM RESPONSIBILITY

2. User selects desired employee.

1. Provides a list of all employees.
3. System determines employee id and determines employee type.
4. If employee is Boss then Do **View Boss**; else Do **View Hourly Worker**.

Select Boss

Is used to select an Boss to view.

USER INTENTION

2. User selects desired boss.

SYSTEM RESPONSIBILITY

1. Provides a list of all bosses.
3. System determines employee id of the boss.
